## EXECUTIVE: 16<sup>TH</sup> JUNE 2011

#### 15/ ANNUAL GOVERNANCE STATEMENT

A report was received on the statement on the control and governance framework within the Council, which was required to comply with the Accounts and Audit Regulations. The report set out relevant statutory powers, background information, a summary of the governance statement and process, options open to the Executive, legal, financial and equalities implications, consultation undertaken and policy framework considerations.

The statement highlighted some areas where improvements were required. The Executive were advised that the Overview and Scrutiny Committee had noted particular concerns regarding health and safety and contract management.

The Deputy Leader provided an update on the actions to respond to the issues, which included a new procurement team structure within Legal Services and contract management tool to support managers. Work had also been undertaken within health and safety to ensure actions were recorded and monitored and the Executive were informed that the Health and Safety Forum would ensure this continued.

The governance statement, attached as annex 1 to the report, would form part of the Council's annual financial accounts for the 2010/11 year. Approval was sought to change the approval process for future accounts to enable auditing to be completed before they are approved.

The Executive noted that invoicing and cash management issues had been resolved as cash payments were no longer accepted at the depot.

#### **RECOMMENDED that:**

(i) Approval of the Statement of Accounts be delegated to the Executive; and

(ii) Article 4 and the Functions and Responsibilities (Local Choice) within the Constitution be amended to reflect the delegation in (i) above, in accordance with the Accounts and Audit Regulations 2011.

**RESOLVED** that the Annual Governance Statement, as set out in annex 1 to the report, be endorsed.

**Reasons for Recommendations / Decision:** To endorse the Council's Annual Governance Statement before it is included within the Council's annual Statement of Accounts, and to agree the process for approval of the Statement of Accounts.
