SUBJECT:	REVIEW OF POLLING DISTRICTS AND POLLING PLACES

RECOMMENDATIONS:

- 1. The premises set out in Annex 1 be designated the polling places for the polling districts stated with effect from 1st January 2015; and
- 2. Taking into consideration any responses to the current consultation on using Reigate Park Church, the Electoral Registration Officer be delegated authority to designate a polling place for the SPW1 polling district of South Park & Woodhatch Ward.

SUMMARY

This report sets out the proposals for polling districts and polling places in the Borough following the statutory review undertaken under the Electoral Administration Act 2006.

STATUTORY POWERS

- 1. The Electoral Administration Act 2013 introduced a change to the timing of compulsory reviews of UK Parliamentary polling districts and polling places.
- 2. Reviews must be started and completed within the period of 16 months that starts on 1 October of every fifth year after 2013. The current review must therefore be completed by 31 January 2015.
- 3. The last statutory review of polling districts and polling places was carried out in 2011.
- 4. Schedule A1 to the Representation of the People Act 1983 sets out all the steps that must be undertaken to complete a review. Officers have also had regard to guidance published by the Electoral Commission.
- 5. In conducting a statutory review Local Authorities are required to demonstrate they have met the criteria set out in the legislation as follows:
 - Seek to ensure that all electors in the constituency have such reasonable facilities for voting as are practicable in the circumstances;

 Seek to ensure that so far as is reasonable and practicable every polling place for which it is responsible is accessible to electors who are disabled.

REVIEW PROCESS

- 6. In accordance with statutory requirements the Council gave notice of the review on Monday 28 July 2014 and sought comments from a wide range of stakeholders including:
 - The Acting Returning Officers for Parliamentary Constituencies within the Borough
 - All Borough Councillors
 - County Council Divisional Councillors for Reigate and Banstead
 - Surrey County Council
 - Horley Town Council
 - Salfords and Sidlow Parish Council
 - MPs for the borough
 - Political Parties
 - Residents Associations
 - Access Groups Eastern Disability Alliance Network / Citizens' Advice Bureau
- 7. The Review information was also available via the Council's web site for public consultation.
- 8. As part of the review process Officers visited all premises currently designated as polling stations along with any identified potential alternative premises and considered existing arrangements against a range of criteria including:
 - Convenience for electors
 - Accessibility
 - Car parking
 - Facilities for staff
 - Health & Safety
- 9. Representations received are detailed in Appendix A including those received from visits to premises carried out by the Eastern Disability Alliance Network and Citizens' Advice Bureau.
- 10. A representation was also received relating to changes in the current Ward Boundaries which is outside the scope of this review.

Accessibility Issues

11. There are still concerns regarding access for the elderly and/or disabled electors at the Meadvale Parish Room polling place in Somerset Road, Redhill. Due to the proximity of the entrance to the highway it is not possible to have a ramped access. Officers have visited a number of alternative venues, but these are either unavailable or unsuitable.

- Comments and concerns about access raised by the representatives of the Eastern Disability Alliance Network and Citizens' Advice Bureau have been passed on to the relevant premises managers.
- 13. A schedule of existing and proposed polling places is attached as **Appendix 1** to this report.

SUMMARY OF PROPOSED CHANGES

14. As a result of the review, two changes are proposed to the designated polling places, as summarised below.

Horley East

- 15. Oakwood School has been the designated polling place in recent elections. However, development of the school has included demolition of the previous polling station. No alternative rooms are available at Oakwood School and in the elections in May 2014 temporary porta cabins were required to operate a polling station.
- 16. An alternative polling place is proposed at Langshott School. This is very close to Oakwood School.
- 17. An objection was received from Horley Town Council due to concerns regarding the school closing on polling days. School closures are a matter for the Head Teacher and Governors of individual schools to determine. Langshott School has confirmed a closure will not be necessary.
- 18. It is therefore recommended that the polling place for Horley East (HOE1) be designated as Langshott School.

South Park & Woodhatch

- 19. Following the consultation closure, the Electoral Registration Officer was informed that St Luke's Church will be undergoing redevelopment during 2015 and will, therefore, not be available for use as a polling place.
- 20. Officers have carried out a review of alternative locations and identified Reigate Park Church in Park Lane East as the preferred location. This is considered a very suitable location with good accessibility. Consultation with Ward Members, Group Leaders and the local MP is currently underway.
- 21. It is therefore recommended that the designation of a Polling place in South Park & Woodhatch (SPW1) be delegated to the Electoral Registration Officer, taking into consideration the outcomes of the current consultation.

LEGAL IMPLICATIONS

22. There are no specific legal implications arising from this report.

RESOURCE MPLICATIONS

23. There are no specific resources implications arising from this report.

CONSULTATION

24. Consultation has been undertaken as set out in paragraphs 6 and 7 of this report.

CONCLUSIONS

25. The Council is obliged to have suitable arrangements in place in order to provide voting facilities for all the electors of the Borough. The process of review is ongoing and Officers will continue to pursue alternative more suitable premises where existing premises fall below the standards sought by the Council.
