

# **Consultation Statement**

**Draft Developer Contributions SPD** 

December 2015



### Introduction

- 1. This document explains how the Council has prepared the Draft Developer Contributions Supplementary Planning Document (SPD) and the proposed approach to public consultation. It has been prepared in accordance with the relevant provisions of the Town and Country Planning (Local Planning) (England) Regulations 2012.
- In accordance with paragraph 153 of the National Planning Policy Framework, the SPD is needed to provide guidance to applicants on the Council's approach to the use of developer contributions to secure the necessary infrastructure required to support growth and in doing so, aid infrastructure delivery.
- 3. The SPD supports the implementation of Core Strategy Policy CS12: Infrastructure Delivery, which itself was subject to extensive consultation during its preparation. Further information about the Core Strategy is available on the Council's website<sup>1</sup>.
- 4. It is intended that this SPD will, upon adoption, replace the Planning Obligations and Infrastructure SPD previously adopted in April 2008 and the Horley Infrastructure Provision SPD adopted in July 2008, which have largely been outdated by legislative changes and the impending adoption of CIL.

## **Preparation of the SPD**

- 5. The draft SPD has been produced by the Council's Planning Policy team in partnership with the Council's Development Management and Legal Services teams.
- 6. The draft SPD has been informed by evidence and supporting documentation prepared to support the Council's Community Infrastructure Levy Charging Schedule. This material is available on the Council's website<sup>2</sup>.
- 7. In particular, a large part of the content of the draft SPD is derived from the Council's *Position Statement on the use of CIL and Section 106 agreements* (*RBBC03*), a document which has already been subject to public consultation during the CIL Preliminary Draft and Draft Charging Schedule consultations. Comments received from stakeholders, including the County Council, during these consultations have informed its development.
- 8. The SPD was reported to the Council's Executive on 7<sup>th</sup> January 2016.

## Scope and methods of consultation

- The purpose of the consultation on the SPD is to allow stakeholders to make representations on the Council's proposed approach to developer contributions.
- 10. Given the nature of the consultation, the Council is undertaking targeted consultation on this SPD. This will include the statutory specific consultation bodies for the purposes of plan-making<sup>3</sup> and the following general consultation bodies and other consultees which the Council considers appropriate and most likely to be affected by the content of the SPD:
  - Other local authorities falling within the Gatwick Diamond area
  - Infrastructure providers
  - Developers
  - Planning agents
  - · Local residents and business groups
- 11.A list of the individuals and organisations drawn from the Council's consultation database that are intended to be directly targeted through the consultation is set out in Annex 1. These groups will be directly notified and invited to comment through postal or email notification.
- 12. In addition, the document will also be made available on the Council's website and in hard copy at the Town Hall for general public comment by any other interested parties.
- 13. In accordance with the Regulations<sup>4</sup>, the consultation will run for a 4 week period beginning in late January 2016.

# Next Steps

- 14. Once the consultation on the SPD has been completed, representations received will be reviewed and considered. These comments will inform the final version of the document with amendments made where appropriate and necessary.
- 15. A summary of number of representations received, the comments made and the key issues raised will be produced. This summary will be reported to the Council's Executive together with the final version of the SPD and will be made publicly available.
- 16. It is anticipated that adoption of the SPD will take place at the same time the Council commences implementation of the Community Infrastructure Levy in spring 2016.
