#### **RECOMMENDATIONS:**

- 1. To approve the Schedule of Meetings for the 2016-17 Municipal Year, as set out in Annex 1 to this report, including the addition of a further meeting of the Executive on 30 June 2016 as recommended by the Overview and Scrutiny Committee.
- 2. Delegate the Monitoring Officer authority to review the Constitution and to make any necessary changes to facilitate the proposed new committee structure.
- 3. To support the Overview and Scrutiny Committee's comments in relation to the proposed new Licensing and Regulatory Committee and that the proposal in relation to the Planning Committee be not supported.

### REASONS FOR RECOMMENDATION:

To establish a timetable to ensure the efficient and effective conduct of Council business for the forthcoming municipal year.

## **EXECUTIVE SUMMARY**

The schedule of meetings for 2016-17 draws upon past experience and has regard to comments from both Members and Officers.

The schedule was considered by the Overview and Scrutiny Committee at its meeting on 10 December 2015 and its comments are noted below.

This recommendation requires approval by Full Council.

# **BACKGROUND**

- 1. Under the Constitution it is for the Council to approve a Schedule of Meetings for the forthcoming Municipal Year.
- 2. A draft Schedule is attached to this report at Annex 1.

### **FACTORS FOR CONSIDERATION**

- 3. The following points might be helpful to Members in considering the draft Schedule:
  - The proposed Schedule builds upon past experience and is designed to ensure that all business is accomplished as efficiently as possible.
  - It is proposed to combine the Council's Regulatory and Licensing Committees into a single committee, in order to improve governance and efficiency as well as to allow Members on the new committee to develop an expertise across all areas of licensing law. If this is agreed in principle, it is proposed that the detailed operating model be developed in discussion with Spelthorne Borough Council, who already operate a combined committee.
  - Amendments may be made, in the course of the year, in the case of unforeseen circumstances. Any changes will be publicly notified as and when they occur.
  - All scheduled meetings are listed in the Centralised Diary, which can be viewed by both officers and members to avoid meeting clashes.
  - An electronic schedule of meeting dates is available to download to Members' personal devices.
- 4. At its meeting on 10 December, the Overview and Scrutiny Committee:
  - a. **supported** the proposal to combine the Council's Licensing & Regulatory Committees into one committee:
  - b. **recommended** the addition of a further Executive meeting on 30 June 2016 to allow for the Statement of Accounts to be considered before the statutory deadline: and
  - c. **suggested** that consideration be given to deferring the Planning Committee meeting on 31 August 2016 by one week.
- 5. The recommendation of adding a further Executive meeting on 30 June 2016 is supported and has been added into the attached Schedule for consideration. The timetable for the preparation of the Statement of Accounts and the legal requirement for it to be approved by 1 July does not allow sufficient time for it to be considered at either the earlier meeting in June or the next meeting in July.
- 6. The suggestion of moving the Planning Committee in August 2016 forward by one week is not supported as this would impact on the regular 4 weekly cycle of business that is in place for these meetings. It is accepted that it is on 31 August and that on the whole August is avoided for meetings, however it is felt that the benefits of retaining the regular pattern of business outweigh the disadvantage of having a meeting on the last day of August.

# **CONSULTATION**

7. Officers, Group Leaders and the Overview and Scrutiny Committee have been consulted on the proposed schedule.
