Premises name - Robins Cooke Farm, Redhill Park, Kingsmill Lane, Nutfield, Redhill, Surrey. RH1 5JX.

Surrey Police, as a Responsible Authority under Section 13(4) (b) of the Licensing Act 2003, wish to make a formal representation to the above application for a premises licence the representation is based on my concerns over one or more of the licensing objectives:

- The prevention of crime and disorder
- Public safety •
- The prevention of public nuisance •
- The protection of children from harm •

If a Licence is granted Police would ask for the following conditions to be imposed.

- 1) The events security plan is submitted to police at least 2 months prior to the event.
- 2) Adequate Security staff are employed by the organisers in line with their security plan.
- . 3). The events Traffic plan to be submitted to Police at least 2 months prior to the event.
- (4) The event organisers to maintain frequent communication with Police prior to and during the event.
 - 5) All drinks to be dispensed in non breakable receptacles.
 - 6) Best endeavours to be used to prevent glass being brought on to the site.
 - 7) Under 16s to be accompanied by an adult.
 - 8) Family camping area to be established.
 - 9) Public footpath to be kept clear of obstructions.
 - 10) Uniformed Police officers to be employed btw 1800 and 0200 on both days. The number of officers to be agreed by Police and the organisers in writing.
 - 11) Continuous during opening hours of the event the searching of all bags on all entrances into the arena with no alcohol being allowed to be taken in.



- 12) Continuous during opening hours of the event intelligence lead pat down searches of persons at all entrances into the arena in order to reduce any controlled drugs being taken in.
- 13) Removal and exclusion from site of any person found to be in possession or using any controlled drugs.
- 14) Security to pro-actively deal with any persons who identified as being under 18 consuming alcohol by removing it from them.
- 15) ID checks to be done on persons believed to be under 21 when purchasing alcohol at the bars.
- 16) Selective searching of persons entering the campsite and the removal of alcohol from persons who are under 18.
- 17) 24hr security patrols of the campsite.
- 18) Pro-active patrolling of the entire site by security to ensure the safety and security of guests.

These conditions are in line with those imposed at the 2012 event and have been agreed by the applicant.
