### Progress in 2015 – 16: Volunteering



Throughout the year VARB promoted volunteering through public and targeted events and via a range of literature. We have used the national volunteer website Do-it to publicise over 180 new opportunities.

Overall 183 volunteers were placed in 2015-16, including

50 corporate volunteers – an area that is growing.

Many volunteers now use web sites such as Do-it to volunteer directly with organisations, so the role of VARB is evolving.

Through the Aspire project VARB provides extra support and guidance to volunteers with additional needs. 31 Aspire volunteers were successfully placed in 2015-16.

A Young Volunteer project was launched in February 2016 using funding from Comic Relief and Reigate & Banstead Borough Council. The project aims to attract more young people into volunteering by highlighting suitable opportunities and working closely with schools and colleges.

A range of training opportunities for volunteers were delivered, in partnership with WEA and St John Ambulance: First Aid, Online Safety, Event Planning and Transferable Skills. Future courses will be informed by the Training Needs Assessment (March 2016).

VARB worked closely with the Borough Council to deliver the Mayor's Volunteer Awards, hosted at Gatton Park in September 2015. It was a great event with many inspiring stories of voluntary work in the Borough.



# Supporting the Voluntary, Community & Faith Sector

Working with the Cinnamon Trust we sponsored a Faith Audit to identify the social and economic impact of faith groups in the Borough. The Audit revealed 474 projects with a financial value of over £5million and led to a greater awareness of the faith sector among public and voluntary organisations. VARB has built on this work to develop closer links with the faith sector.

The Building Better Partnerships project, funded by The Big Lottery, took place from September 2015 to August 2016. VARB collected information, from over 70 local organisations, about the resources they needed and could offer in the areas of skills, transport and premises. This culminated in a Matchmaking Event for organisations and a Directory of Resources to broker partnerships and help with the sharing of resources within the sector. There are plans to build on this work in 2016-17 to request resources from the local business community.



In February 2016 over 100 people attended the Funding Fair, held in partnership with Tandridge Voluntary Service Council, to hear funding advice from the Big Lottery, Community Foundation for Surrey and other funders. VARB also launched monthly Funding Surgeries offering individual funding searches and advice.

VARB held a further 4 networking events throughout the year, including a Moving Forward workshop and Network Lunch for Volunteer Managers.

#### Other News

A new trustee, Alisdair Semple, joined the board in 2015-16 along with 4 new members of staff: Caroline Foxton, Chrissy McDougall, Nina Porter and Alice Patterson.

In February 2016, the organisation rebranded from Reigate & Banstead Voluntary Services (RBVS) to Voluntary Action Reigate & Banstead (VARB) and launched our new web site www.varb.org.uk.
