SUBJECT:	SCH	EDULE OF MEE	TINGS 2018-19	

**RECOMMENDATION:** The Overview and Scrutiny Committee is invited to comment on the draft schedule of meetings for 2018-19.

## SUMMARY

The purpose of the Schedule of Meetings is to set a suitable timetable for the efficient and effective conduct of Council business during the municipal year.

The comments of the Overview and Scrutiny Committee will be reported to the meeting of the Executive on 11 January 2018.

The proposed Annual Schedule of Meetings will then be considered by full Council at its meeting on 8 February 2018.

## **BACKGROUND**

- 1. Under the Constitution it is for the Council to approve a Schedule of Meetings for the forthcoming Municipal Year.
- 2. A draft schedule is attached to this report at Annex 1.

## **FACTORS FOR CONSIDERATION**

- 3. The following points might be helpful to Members in considering the draft schedule:
  - The proposed schedule builds upon past experience and is designed to ensure that all business is accomplished as efficiently as possible.
  - The deadline for the External Auditors to issue the ISA 260 audit report on the Council's annual Statement of Accounts has been brought forward. The Executive meeting has therefore had to be set for 19 July to accommodate this.
  - The audit report then has to be presented to Council for approval. The options for setting the Council date are therefore the end of July or the beginning of August. As Members have expressed a desire not to have meetings in August the implications of holding the meeting in July are set out below:
    - Thursday 26 July, in which case the Executive recommendations (in relation to the Statement of Accounts and any other matters requiring Council approval) would not be ready to go out with the Council agenda and would have to be marked as 'to follow'; or

- Thursday 2 August, which would allow adequate time for the papers to be circulated with the agenda.
- Members are invited to consider these two options and to decide which date is preferable for recommendation to the Executive.
- A meeting of the Planning Committee is scheduled for Wednesday 1 August in order to avoid having a six week gap between meetings, which would be the case if it were to be set for the previous week.
- As in previous years, meetings of the Licensing & Regulatory Committee and its sub-committees, as well as those of the Executive Sub Committees, have not been scheduled except for the initial meeting to make appointments to the chair.
- Amendments to the schedule may be made at any time in the course of the year, in the case of unforeseen circumstances. Any changes will be publicly notified as and when they occur.
- Following conclusion of the Boundary Commission Review, there will be all-out elections in 2019, and meetings have therefore been avoided in the run-up to allow members to concentrate on canvassing and other activities associated with the election.
- All scheduled meetings will be listed in the Centralised Diary, which can be viewed by both officers and members, to avoid meeting clashes.
- An electronic schedule of meeting dates will be available to download to Members' personal devices.

## CONSULTATION

Any comments by the Overview and Scrutiny Committee will be reported to the Executive at its meeting on 11 January 2018.
