Regional Thai Taste, 38A High Street Reigate Surrey RH2 9AT

This application by Justice Haynes is to vary the existing Premises licence (21/01316/LAPREM) which operates as a restaurant/lounge bar. The applicant has requested permission to vary the licensable activities hours during the end of week period Thursday to Saturday only. This will bring the premises in line with other premises that operate in the 'late-night economy sector' in Reigate town centre. The variation also seeks to add a licensable activity 'Anything of a similar description falling under Music or Dance' and increases the Premises opening hours.

The hours of the present licensable activities are:

Retail sale of alcohol (on and off premises)

Sunday to Wednesday 12:00 - 00:00

Thursday 12:00 - 00:45

Friday and Saturday 12:00 - 01:15

Live Music

Sunday to Wednesday 12:00 - 00:00

Thursday 12:00 - 00:45

Friday and Saturday 12:00 - 01:15

Recorded Music

Sunday to Wednesday 12:00 - 00:00

Thursday 12:00 - 00:45

Friday and Saturday 12:00 - 01:15

Late Night Refreshment

Sunday to Wednesday 23:00 - 00:00

Thursday 23:00 - 00:45

Friday and Saturday 23:00 - 01:15

The premises opening hours are Sunday to Wednesday 12:00 - 00:00, Thursday 12:00 - 01:00 and Friday and Saturday 12:00 - 01:30.

The variation seeks no change to the timings of any licensable activity Sunday to Wednesday, but as stated seeks to increase the hours during the end of the week period Thursday to Saturday. This change applies to the addition of 'Anything of a similar description falling under Music or Dance' which follows this profile and is requested as:

Supply of alcohol

Thursday to Saturday 1200 - 01:45

A Seasonal variation for the retail sale of alcohol on New Year's Eve until 02:45.

The premises opening hours Thursday to Saturday 12:00 - 02:00.

The following additional mediated conditions were agreed with the Police following their objections:

- 1) A minimum of 3 door supervisors on a Thursday, Friday and Saturday night, Christmas Eve, and New Year's Eve, to be employed from 20:00hrs until the venue closes and patrons have dispersed.
- 2) On any other day of the week a minimum of 3 door supervisors when regulated entertainment is taking place and the venue is to be open beyond 2300hrs.
- 3) A personal licence holder shall be on duty from 2000hrs on a Thursday, Friday, Saturday, Christmas Eve, New Year's Eve and from 2000hrs on any other day when regulated entertainment takes place beyond 2300hrs.
- 4) There shall be no more than 5 persons in the dedicated smoking area at any one time. The smoking area shall be monitored by staff to ensure the orderly.
- 5) There shall be no drinking vessels taken outside the building onto the front entrance route into the premises, from the High Street.

- 6) There shall be no admittance or re admittance after 2300hrs into the venue, when regulated entertainment is taking place.
