PURPOSE OF THE REPORT:	TO DETERMINE THE REVIEW APPLICATION

OPTIONS

The Committee, having regard to the application and any relevant representations, may take such steps as mentioned below (if any) as considered appropriate for the promotion of the licensing objectives:

- (a) modify the conditions of the licence;
- (b) exclude a licensable activity from the scope of the licence;
- (c) remove the designated premises supervisor;
- (d) suspend the licence for a period not exceeding three months;
- (e) revoke the licence;

Where the authority takes a step mentioned in (a) or (b), it may require the modification or exclusion to have effect for a limited period not exceeding three months.

The Committee has authority to determine the above options.

Background

- The current premises licence for Joules Wine and Cocktail bar reference 18/03964/LAPREM is attached at Annex 1. This licence was issued in July 2018, as a result of a minor variation application. Following an intervention from the police licensing officer, conditions 1 to 12 in Annex 2 of the licence were voluntarily included on the licence.
- 2. A location plan showing adjacent properties in Bell Street, and other town centre properties in High Street and Church Street is attached at Annex 2.

Application

- 3. The application to review the premises licence was made by Angie Austin, Borough Inspector. The representation is attached at Annex 3 and relates to the following licensing objectives;
 - (a) The prevention of crime and disorder
 - (b) Public safety
 - (c) The protection of children from harm
- 4. Additional information in support of the police application was presented to Mr Cummings and Mr Carey on 11 March 2020 by Ian Sandwell, Police licensing officer. This information includes CCTV evidence which is the subject of ongoing criminal proceedings and therefore exempt from the public meeting. Two timeline documents detailing the CCTV evidence in support of the police application were supplied to the licence holder on 2 April 2020
- 5. Annex 4 contains an extract from the confidential information detailed above. This document lists the measures proposed by the police in order to promote the licensing objectives referred to in paragraph 3 above

Representations

- 6. A representation was received from the responsible authority for Environmental Protection. The representation is included at Annex 5 and advises that the licence in respect of live and recorded music has the ability to cause public nuisance. It further explains that the operating schedule does not contain sufficient measures to promote the licensing objectives. Several proposed measures are included in the representation, which in the view of the responsible authority will promote the licensing objective, prevention of public nuisance.
- 7. No further representations were received

Policy and Legal Considerations

8. Relevant to this application are sections 6 to 9 of the Council's Statement of Licensing Policy – The Licensing Objectives, Section 149 Equality Act 2010 -Public Sector Equality Duty, Human Rights Act 1998. Licensing Act 2003; Part 2 Licensing Authorities (sections 4-6); Part 3 Premise Licences (sections 51-53); section 182 Home Office guidance; section 183 Hearings and other matters considered relevant on the facts.

Appeals Procedure

9. In cases where an application for a review of a premises licence is either rejected or granted, in full or in part, an appeal may be made to the Magistrates Court within 21 days beginning with the day on which the appellant was notified of the decision. The rights of appeal are available to the applicant, the holder of the premises licence or any other person who made relevant representation. Any determination does not have effect--

- (a) until the end of the period given for appealing against the decision, or (b) if the decision is appealed against, until the appeal is disposed of.

Annex 1 – Mandatory conditions

1 Premises Licence, Sale of Alcohol permitted

"No supply of alcohol may be made under this licence

- a. At a time when there is no designated premises supervisor in respect of it or,
- b. At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended"

"Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence."

2 Premises Licence, Films permitted

The admission of children under the age of 18 to film exhibitions permitted under the terms of this licence shall be restricted in accordance with any recommendations made

- a. By the British Board of Film Classification (BBFC,) where the film has been classified by that Board, or
- b. By the Licensing Authority where no classification certificate has been granted by the BBFC, or, where the licensing authority has notified the licence holder that Section 20 (3) (b) (74 (3)(b) for clubs) of the Licensing Act 2003 applies to the film.

3 Premises Licence, Door Supervisors

Only individuals licensed by the Security Industry Authority may be used at the premises to guard against:-

- a. unauthorised access or occupation (e.g. through door supervision), or
- b. outbreaks of disorder, or
- c. damage

NB This condition will only be imposed where the premises licence contains a condition that at specified times one or more individuals must be at premises to carry out the activities specified in the above condition. The condition is not mandatory in respect of premises:-

- * with premises licences authorising the performance of plays or films
- * being used exclusively by a club with a club premises certificate
- * under a TEN authorising plays or films
- * under a gaming licence .(but see Licensing Act S21(2)(b))
- * being used for an occasion prescribed by regulations under the SIA.

The Licensing Act 2003 (Mandatory Licensing Conditions) (Amendment) Order 2014

- 1. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
- (a)games or other activities which require or encourage, or are designed to require or encourage, individuals to—
- (i)drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii)drink as much alcohol as possible (whether within a time limit or otherwise);
- (b)provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;

- (c)provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d)selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e)dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- 2. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 3. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
- (a)a holographic mark, or
- (b)an ultraviolet feature.
- 4. The responsible person must ensure that—
- (a)where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—

(i)beer or cider: ½ pint;

(ii)gin, rum, vodka or whisky: 25 ml or 35 ml; and

(iii)still wine in a glass: 125 ml;

- (b)these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c)where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available."

The Licensing Act 2003 (Mandatory Conditions) Order 2014

- 1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purposes of the condition set out in paragraph 1—
- (a)"duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- (b)"permitted price" is the price found by applying the formula—

P = D + (DxV)

where-

- (i)P is the permitted price,
- (ii)D is the rate of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii)V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c)"relevant person" means, in relation to premises in respect of which there is in force a premises licence—
- (i) the holder of the premises licence,
- (ii)the designated premises supervisor (if any) in respect of such a licence, or
- (iii)the personal licence holder who makes or authorises a supply of alcohol under such a licence;

- (d)"relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e)"valued added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Annex 2 – Conditions consistent with the Operating Schedule

Providing a 30-minute extension of opening hours after the end of the sale of alcohol will promote this objective as the last drink will be consumed less quickly, with access to the pub's toilet facilities Regular liaison with Police

Zero tolerance policy on the use or supply of drugs.

The fire safety measures with which the premises are provided, will be maintained in good working order, and their adequacy will be determined on a regular basis, by carrying out a fire risk assessment. As the safety of occupants is influenced by numbers of persons present, their disposition and the activities taking place, a safe occupancy level will be maintained. No risks are identified that are not covered by other legislation.

All regulated entertainment will end at least half an hour before the supply of alcohol. Regular noise checks during regulated entertainment. Outside areas kept clean and tidy and bins emptied quietly. No drinks taken off-site apart from off-sales.

- 1 CCTV shall be installed on the premises and fully maintained, showing correct date and time information. The CCTV will cover internal public areas and external doorways, smoking area, beer garden and the external areas at the front of the premises, including the frontage on Bell Street. The CCTV shall provide clear images of evidential quality and shall capture images of people entering and exiting the premises. The premises licence holder must ensure that staff are able to make copies available at the request of the Police or other authorised licensing authority within 24 hours. CCTV footage must be retained for minimum of 31 days.
- 2 The Premises Licence Holder shall employ a minimum of 3 SIA door supervisors when the premises is operating on a Friday and Saturday, until 0230hrs. (One SIA door supervisor shall start at 2000hrs and the other two SIA door supervisors shall start at 2100hrs). A door supervisor will supervise the beer garden/ smoking area, at all times the venue is open for business.
- 3. The Premises Licence Holder shall risk assess the requirement for door supervisors on days other than a Friday and a Saturday, to include a Thursday night, seasonal variations and the day preceding a bank holiday.
- 4. A personal licence holder shall be on the premises, when the premises is open for business after 2100hrs.

- 5. The Premises Licence Holder shall ensure that patrons are counted in and out of the venue to comply with capacity limits for the premises. A written record of the number of persons on the premises, will be recorded at hourly intervals after 2100hrs until the premises is closed. These records are to be retained for twelve months and available to inspection by a police officer or other responsible authority.
- 6. Staff training shall be undertaken on appointment and updated every 6 months. Training delivered to staff shall be recorded .Training shall cover:
 - The licensing objectives
 - The requirements for ID as part of age verification.
 - Dealing with an intoxicated person
 - Dealing with disorderly incidents/disorderly persons
 - Dealing with drug related activity on a licensed premises
 - Recording of any refusal to sell alcohol
 - Recording of incidents
 - Reporting of incidents to police and information to be shared with police to promote the licensing objectives
 - All training records will be available to an authorised officer on request
 - An incident log shall be maintained on the premises documenting the date and time of any incidents involving the premises which could undermine the four licensing objectives. This shall be completed within 24 hours of the incident, be available upon request of a police officer or an authorised officer and will record the following:
 - 1 All crimes reported at the venue
 - 2 All ejections of patrons
 - 3 Any complaints received concerning crime and disorder
 - 4 All drugs seized or found
 - 5 Any incidents of disorder
 - Any faults in the CCTV system, including action taken to remedy
 - 7 Persons banned from the premises
 - 7. There shall be a record of any refused sale of alcohol. The refusal register shall be inspected on a regular basis (at least weekly) by the DPS or a personal licence holder and endorsed accordingly.
 - 8. The Premises Licence Holder shall adopt a 'Challenge 25' policy, as a condition of entry into the premises.
 - 9. The Premises Licence Holder shall have a drugs policy for the venue.
 - 10. The toilets shall be checked hourly and a record of these checks maintained by the venue for a period of three months.
 - 11. Signage shall be displayed in a prominent position on the premises requesting that customers leave quietly and respect the neighbourhood.
 - 12. The premises will have a dispersal policy to ensure patrons safely disperse from the premises.

Embedded Restrictions

1 Entertainment

The appropriate sections of the Regulations and Conditions for Entertainment Licences dated August 1996 issued by Reigate and Banstead Borough Council apply.

The following special conditions also must be adhered to:-

2 Permitted Hours General


"Alcohol shall not be sold or supplied except during permitted hours. In this condition, permitted hours means:

- a. On weekdays, other than Christmas Day, Good Friday or New Year's Eve, 10 a.m. to 11 p.m.
- b. On Sundays, other than Christmas Day or New Year's Eve, 12 noon to 10.30 p.m.
- c. On Good Friday, 12 noon to 10.30 p.m.
- d. On Christmas Day, 12 noon to 3 p.m. and 7 p.m. to 10.30 p.m.
- e. On New Year's Eve, except on a Sunday, 10 a.m. to 11 p.m.
- f. On New Year's Eve on a Sunday, 12 noon to 10.30 p.m.
- g. On New Year's Eve from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day (or, if there are no permitted hours on the following day, midnight on 31st December).

The above restrictions do not prohibit:

- (a) the consumption of the alcohol on the premises during the first twenty minutes after the above hours;
- (b) the taking of the alcohol from the premises, (unless the alcohol is supplied or taken in an open vessel,) during the first twenty minutes after the above hours;
- (c) the consumption of the alcohol on the premises by persons taking meals there during the first thirty minutes after the above hours, if the alcohol was supplied for consumption ancillary to those meals;
- (d) consumption of the alcohol on the premises by, or, the taking, sale or supply of alcohol to any person residing in the licensed premises;
- (e) the ordering of alcohol to be consumed off the premises, or the dispatch by the vendor of the alcohol so ordered;
- (f) the sale of alcohol to a trader or club for the purposes of the trade or club;
- (g) the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces;
- (h) the taking of alcohol from the premises by a person residing there; or
- (i) the supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied; or
- (j) the supply of alcohol for consumption on the premises to persons employed there for the purposes of the business carried on by the holder of the licence, or the consumption of liquor so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the premises."

Surrey Police are making this premises licence review application based on incidents reported to police which are linked to the licensed premises called Joules Wine and Cocktail Bar. Surrey Police believe the above licensing objectives are not being promoted by the management of the licensed premises and this application seeks to address those concerns.			
Surrey Police have established that a person under the age of eighteen has been able to access the licensed premises.			
Reports received by Surrey Police, link the licensed premises to public disorder. Intoxication is evident in a number of these incidents of public disorder.			
Surrey Police have concerns for the public safety of patrons on leaving the licensed premises.

The following information is extracted from the confidential information provided by the police in support of the review application

Surrey Police, having met with the premises licence holder on Monday 20th January 2020, set out conditions which police sought to be added to the premises licence by the premises licence holder. This attempt to mediate conditions in the promotion of the licensing objectives has subsequently not been supported by the premises licence holder and the actions proposed in response by the premises licence holder are not satisfactory and there is no agreement to amend the premises licence.

In light of this failure to mediate conditions, Surrey Police are left with no option but to submit this review to seek conditions that mitigate against the poor management these incidents have highlighted and to ensure the licensing objectives are being promoted within the establishment above everything else.

In addition to the conditions reference above, surrey police have further identified that CCTV coverage of the dance floor in Joules, requires upgrading, to improve picture quality that would support the licensing objectives.

Surrey Police are therefore asking the licensing committee to consider the following conditions being applied to the premises licence, to promote the crime and disorder, the prevention of children from harm and public safety licensing objectives:

- ID Scanning shall be a condition of entry to the licensed premises. ID scanning of a patrons
 passport, driving licence or pass card, shall take place when entering the premises on every
 occasion .Where a person refuses to allow an approved ID to be scanned, they shall be
 refused entry. The ID scanning capability shall include facial recognition and authentication
 of the approved ID presented.ID scanning to be conducted in a location where the CCTV at
 the premises can record each procedure.
- 2. In the event that the ID scanner is not working, each patron entering the premises must be photographed or filmed and that record retained for a minimum of 31 days. A record of the failure must be recorded in a log and the police notified, together with the steps taken to have the ID Scanner repaired/replaced at the earliest opportunity.
- 3. No patrons under the age of 21 shall be admitted onto the licensed premises.
- 4. The premises shall have a written search policy, which shall require the consent of a patron to a voluntary search as a condition of entry. The policy to include a minimum search ratio of 1 in 4 persons being subject to a voluntary search, as a condition of entry. The written search policy to be available for inspection at the venue by a police officer or authorised officer.
- 5. Annex 2 condition 2, to be amended to state the minimum number of SIA employed shall be 4 SIA door supervisors .All 4 SIA door supervisors to be on duty by 2100hrs until closing and dispersal.
- 6. Annex 2 condition 12, to be amended, so that the dispersal policy, to ensure safe dispersal of patrons, shall be in a written format, available on the premises for inspection by the police or authorised officer and the policy to include door supervisors wearing reflective jackets when at the front of the premises.

- 7. Persons purchasing alcohol at the bar will be required to show proof of age if they appear to be under 25 years of age.
- 8. CCTV coverage of the dance floor to be of an evidential standard, providing clear images of patrons on the dance floor and covering all areas of the dance floor.

The removal of the existing DPS, Mr Michael Carey is also sought by Surrey Police.

Surrey Police recognise that by reducing the hours the premises is allowed to sell alcohol and to stay open, it is likely to have a positive impact on reducing the risk of intoxicated patrons leaving the venue and being on the highway, placing themselves and other road users at risk.

Reducing the operating hours and drinking time will also have a positive impact on the number of assaults reported to police inside the venue and outside the venue on closing, which have a link to the venue.

Surrey Police believe that to reduce the level of intoxication, level of violence and associated risks to patrons, the premises should close at 00:30hrs and no sale of alcohol after 00:00hrs.

Surrey Police believe that the above conditions and consideration of the operator's hours to reduce consumption are necessary and proportionate to promote the licensing objectives of the prevention of crime and disorder, the protection of children from harm and public safety.

Should the licensing committee be minded to implement conditions as set out by surrey police, then suspending the premises licence, whilst the conditions are being adequately implemented, would ensure the licensing objectives are being promoted above everything else.

As a responsible authority as defined in section 13(4)(e) of the Licensing Act 2003 we hereby make representation in respect of the premises known as Joules Wine Bar, 85 Bell Street, Reigate, Surrey.

The reason for making representation is that the current licence in respect of the live and recorded music have the ability to cause public nuisance and the operating schedule does not contain sufficient measures to promote the licensing objectives.

There are 29 residential flats within 50m radius with some immediately adjacent to the premises and we have received noise complaints in the past from local residents:

- 20.07.2019 Excessively loud music from the bar the vibrates my windows with bass from approx 8:30pm until 2:30am. Queue for bar placed outside my windows, and not outside their own premises where there is adequate space to do so. Some people knock on my windows or bang on my windows. Lots of shouting outside the windows. People smoking outside my windows in the queue for the bar, living room and bedroom smell like cigarettes Noise App recordings made
- 23.07.2018 After 11pm Thursdays to Saturdays the noise from people in the beer garden is so loud.
- 09.07.2018 We are all delighted by the success of the England football team, but to have to put up with "football's coming home" being bellowed on Saturday night from the time you opened until closure without any noise monitoring, displayed the utmost contempt for your neighbours some of whom (myself included,) were kept awake until gone 2am and some had to get up at 5am to go to work! Even earplugs failed to reduce the noise!!
- 02.07.2018 Continuous heavy bass notes from music being played. Screaming and shouting from the customers.

For the prevention of public nuisance due to the proximity of residential premises to the licensed premises, and previous complaints I am putting forward the following conditions:

Prevention of noise break out from the premises:

- All windows and external doors shall be kept closed between 19:00 hours and 02:30hours, or at any time when regulated entertainment takes place, except for the immediate access and egress of persons.
- The premises shall ensure that any regulated entertainment provided at the
 premises shall not cause a disturbance to local residents. At all times any noise
 shall be inaudible in any residential property, the test of which is that it shall be
 no more than barely audible at the boundary of any residential property.
- While any regulated entertainment takes place, a member of staff shall at least once an hour undertake monitoring of noise levels at the boundary of the

nearest noise-sensitive locations (as defined in within the 50m radius on the attached map) A written record shall be kept of any monitoring, including the date, time and location of monitoring; and any action taken. Records shall be kept for no less than six months and shall be made available upon request by a police officer or an authorised officer of Reigate and Banstead Borough Council.

- Speakers shall not be located/operated in the entrance lobby or outside the premises.
- Staff and/or door staff shall monitor customers smoking outside the premises on a regular basis and ensure patrons do not cause a public nuisance.

Use of a last entry time for the premises

- There shall be no admittance or re-admittance to the premises after 23:00hours.
- Signs advising of the curfew to be prominently displayed at the entrance to the premises and also on their website/online communications

Effective management of external areas

- Notices shall be prominently displayed at any area used for smoking,
 requesting patrons to respect the needs of local residents and use the area quietly.
- Staff shall monitor customers smoking outside the premises on a regular basis and ensure patrons do not cause a public nuisance.
- Patrons permitted to temporarily leave and then re-enter the premises, eg. to smoke, shall not be permitted to take drinks or glass containers with them after 22:00hours

Prevention of customers causing disturbance when leaving the premises

 Notices shall be prominently displayed at all exits requesting patrons to respect the needs of local residents and leave the area quietly. The licence holder shall enter into an agreement with a hackney carriage and/or private hire firm to provide transport for customers, with contact numbers made readily available to customers, who will be encouraged to use such services.

This is a new premises licence application made by Bubush Ltd., for a café and restaurant the ground floor of the above premises. A previous restaurant on this site was known as Little Tuscany. The only licensable activity applied for is the sale of alcohol from 11:00 hrs until 23:00 hrs Friday and Saturday, 21:00 hrs Monday to Thursday and 18:00 Sunday.

The following mediated conditions were agreed with the Police following their objection;

- 1. CCTV shall be fully maintained, showing correct date and time information. The CCTV will cover areas within the premises used for licensable activity, consumption and the smoking area. The CCTV shall provide good quality images of people entering and exiting the premises. The premises licence holder must ensure that staff are able to make copies available at the request of the Police or other authorised licensing authority within 48 hours. CCTV footage must be retained for minimum of 31days.
- 2. Staff training for licensable activity, shall be on appointment, be recorded and refreshed every 12 months. Training shall cover:
- The licensing objectives.
- The requirements for ID as part of age verification.
- Dealing with an intoxicated person & disorderly incidents /disorderly persons.
- Dealing with drug related activity
- Recording of any refusal to sell alcohol
- Recording of incidents
- Reporting of incidents to police and information to be shared with police to promote the licensing objectives
- Safeguarding of children in licensed premises
- 3. An incident log shall be maintained on the premises, which documents the date and time of any incidents involving the premises, which could undermine the licensing objectives. This shall be completed within 24 hours of the incident, be available upon request of a police officer or an authorised officer and will record the following:
- All crimes reported at the venue
- All ejections of patrons
- · All drugs seized or found
- Any incidents of disorder
- Any incidents relating to safeguarding
- Any faults in the CCTV system, including action taken to remedy
- Persons banned from the premises
- 4. There shall be a record of any refused sale of alcohol. The refusal register shall be inspected on a regular basis (no less than weekly) by the designated premises supervisor or a personal licence holder and a record made of the inspection.

5. The premises licence holder shall ensure a 'Challenge 21/25'policy is adopted within licensable areas at all times. Signage of the 'Challenge 21/25'policy shall be prominently displayed on the premises.
