Application ref: 22/00174/LAPREM FABBRO, 82 High Street, Reigate, RH2 9AP

The applicant VGN Charm Ltd has applied for the variation of an existing Premises Licence for a cocktail bar and desert parlour. The application was to increase the hours for sale of alcohol and add the activities of late-night refreshment and recorded music. Proposed terminal hours to increase from 23:00hrs for sale of alcohol to 01:00hrs daily and opening hours from 23:30hrs to 01:00hrs daily. Recorded music and late night refreshment until 01:00hrs daily.

The following mediated conditions and amended hours were agreed with the Police following their objections:

- 1. On Fridays, Saturdays, Christmas Eve and New Year's Eve, there will be a minimum of two SIA approved door staff to be employed from 20:00hrs until the premises closes and patrons have dispersed. On any other day when the premises are open after 2330hrs, the premises licence holder will complete a written risk assessment to determine if door supervisors are required (there will always be a minimum of two door supervisors). The written risk assessment to be made available to the police or authorised persons for up to 12 months from the date of the event.
- 2. On Fridays, Saturdays, Christmas Eve, New Year's Eve and any other day when the premises are to remain open after 2330hrs, a personal licence holder shall be present on the premises from 20:00 hours until the venue has closed and patrons have dispersed.
- 3. There will be no admissions or re admissions after 2330hrs.
- 5. Tables and chairs outside at the front of the premises shall be removed from 1900hrs.
- 6. The hours applied for until 01:00hrs every day for sale of alcohol, late night refreshment and recorded music have been reduced. The closing time of the premises will now be 23:30hrs on Sunday, Monday and Tuesday, 00:00hrs on Wednesday and Thursday and 01:00hrs on Friday and Saturday. The sale of alcohol and recorded music will finish 15 minutes before closing time. The hours for late night refreshment will be from 23:00hrs to 00:00hrs on Thursdays and from 23:00hrs to 01:00hrs on Friday and Saturday.
