1. Introduction

- 1.1. The Reigate Shop Front Supplementary Planning Document (SPD) provides detailed guidance on the design of the shop fronts located within the Reigate Town Centre Conservation Area, with a view to preserving and enhancing its historic character.
- 1.2. The Council's policy for the design of shop fronts is specified in Development Management Plan (DMP) policies DES10: Advertisements and shop front design and NHE9: Heritage assets. The SPD provides design guidance in relation to all elements of shop fronts in Reigate Town Centre Conservation Area, including frame and fascia, display area, signage, blinds and shop security measures. On adoption, this SPD will replace the current guidance set out in the adopted version of the Reigate Shop Front Design Guide Supplementary Planning Guidance 1993 (revised in 1999). Having clear, up to date guidance adopted will help developers and the Council in implementing DMP policy.
- 1.3. This Initial Consultation Statement has been prepared to accompany the draft SPD for the formal consultation in accordance with the relevant legislation¹. These require a Consultation Statement to be prepared to accompany the draft SPD which the Council makes available for comments through the formal consultation. This Initial Consultation Statement should state:
 - Who the Council consulted when preparing the SPD
 - A summary of the main issues they raised, and
 - How those issues have been addressed in the SPD.

2. Preparing the SPD

2.1. The process of preparing this draft Supplementary Planning Document (SPD) has followed legal requirements² and the requirements as set out in the Council's <u>Statement of Community Involvement in Planning (SCI)</u> (April 2019). The SCI summarises how the Council will engage its communities in its planning functions, including in the preparation of Supplementary Planning Documents (SPDs). The process is summarised in **Figure 1** below.




Figure 2: Timeline for preparation of the SPD

2.2. In preparing the Reigate Shop Front Design SPD, we involved and sought the views on early drafts from the individuals and organisations listed in **Table 2** below. Their suggestions were incorporated into the draft SPD for consultation.

Next Steps

- 2.3. The Council will hold a statutory public consultation on the draft SPD for a minimum of four weeks, when we will invite comments by emailing and writing from interested parties³, and we will make the documents available on our website, and in paper format in the main Town Hall and at the six libraries in the borough. This consultation is currently timetabled for January 2020.
- 2.4. Following the formal consultation stage, the draft SPD will be amended to take account of consultation responses received and any further relevant information. This Consultation Statement will also be updated with a list of who we consulted, a summary of the comments received, and how those comments have been addressed in finalising the SPD. Following its adoption, the SPD will be a material consideration used in determining planning applications and appeals.
- 2.5. On adoption of this SPD, which is currently anticipated to be April 2020, the Council's existing 1999 "Reigate Shop Front Design Guide" Supplementary Planning Guidance (SPG) will be revoked.
